# W-Dog (Wild Dog Optional Gratuity) Sub Committee

The W-DOG model was developed by Council in consultation with stakeholders to encourage landholders to develop innovative measures to assist with the control of wild dogs.

Council in the 2015-2016 budget allocated a gross amount of \$50,000 to support the W-DOG model. This allocation is over and above the allocation for Pest Management of \$500,000.

Advertisements were placed in newspapers, Council's Regional Roundup and staff actively engaged syndicate leaders and landholders encouraging the lodgement of applications for funding under this Model.

The W-DOG Sub-Committee held Round two of assessing applications on 2 March, 2016 where 6 applications were received and assessed. The balance for distribution from BTRC after Round 1 allocations - \$20,607 The underspend from the Drought Assistance Program - \$23,848.40 A total of \$44,848.40 was allocated by the Sub-Committee.

# **Blackall Fitness Centre**

Funding was acquired for the construction of a Fitness Centre in Blackall. The Fitness Centre is to be located at the Blackall Showground. There have been general discussions on the site location and there are 3 proposed areas.

Option 1: Location is alongside the rear of the pool fence area parallel to the main road entrance to the showground.

Option 2: Location is the old netball courts area close to the SES shed and old Girl Guide shed.

Option 3: Location is either to join the new building or as a separate building in front or alongside the Girl Guide shed.

Option 1 & 2 locations will require extra expenditure on this project as new water and sewerage mains will need to be constructed. Option 2 on advice from GBA will require Engineering reports on the Fitness Centre if it was to be built on top of the old concrete courts along with specified plans relating to footings on the old concrete court.

Option 3. Sport & Rec (Debbie Hall) advised that the new Fitness Centre can be either joined to the old Girl Guide shed or can be a separate building alongside or in front of this shed. The financial savings by locating the proposed building in this area is that Water and Sewerage is already located to the old building. There are 2 toilets located in the current building (In last months report I advised there were 3 this was incorrect) and would only require the installation of 2 shower areas.

# **Disposal Of IPads Used For Council Meetings**

These iPads were purchased for the use in Council meetings in January 2012 for \$720 each including GST. The devices have been used to relay data and information between Councillors, CEO and executive management electronically and are also used for council meetings.

The standard useful life of these tablets (iPads) is three years and Council has had them in use for 4 years and will need replacing. The value of each device after depreciation is approximately \$65. To reset device back to factory settings will approximately take about 1 hour which consists of testing and tagging, collection of data from device and resetting which would total around \$40 per device. Therefore each device will be valued at around \$25 when ready for disposal.

These iPads will not be used by the new Councillors in the new term and council has no further use for these devices.

# **Development Application – Reconfiguring a Lot**

An application was received for a Development Permit for Reconfiguring a Lot (Boundary realignment) on land at 'Thrungli' 3302 Tumbar Road, and 'Tralee' 786 Blackall Stock Route Road, Blackall (described as Lot 1 on SP273894 and Lot 1 on SP273899).

Proposed Lot 1 has an area of 15,230ha and proposed Lot 2 has 13,840ha, which we note are the same area calculations as the existing lots. The reason being the proposed boundary realignment effectively represents a "land swap" between the two lots, aligning the common boundary with an existing fence-line (confirmed by Andrew Bell from Murray & Associates).

The proposal seeks to maintain all existing services and vehicle access arrangements, and continue the existing land use and operation.

#### Wilderness Way Public Art Workshop

The Wilderness Way project was held over four afternoon workshops in Tambo facilitated by professional stencil and aerosol artist, Christian Griffiths. The youth of the Tambo explored the tourist loop gaining an understanding of the uniqueness that is located in 'their own backyard'. They collaborated this knowledge into a design into a public art piece with the anticipation of it being display permanently in Tambo's main street. From Community consultation four options were recognised as a potential place to install the public art: These are:

## Option 1:

Tambo Dam – Can be accessed by travellers regularly stopping to utilise the amenities, Caltex roadhouse and picnic sites along another of Tambo's tourist attractions of the Tambo Dam. As shown in the image placing the signage on the corner of the lawn space will draw motorist's attention from the road as it won't by the dam itself. Only concern received was Caltex could be possibly extending their building therefore might need to be mindful of blocking of vision of public art piece.

## Option 2:

Tambo tourist information Centre – Ideally the artwork can be displayed to be tied into the centre where the tourist can easily access this. It would be best mounted along the front fence to ensure the building can be visually seen properly. Only concern is the permanent water system at the police station could damage artwork from water staining.

## Option 3:

EE Parr OBE Park – There is three potential sites at the local park. Tourist utilising the facilities will be able to see the sign, however passing motorist not as visual especially from one direction. The water system is not permanent therefore staining shouln't be an issue. See images below of the three possibilities.

Cnr Dawson Developmental Rd and Landsborough Hwy – The vacant block where the truck sculptures could be ideal for the signage. Would be seen by motorist travelling via two main roads.

#### Regional Arts Development Program – 2016/2017 Program

The Regional Arts Development Fund (RADF) is a highly successful partnership between Arts Queensland and Blackall-Tambo Regional Council that supports local arts and cultural activities in the region.

Applications for the 2016/2017 RADF program are due on May 25th, the Blackall-Tambo RADF program has historically been one of the strongest programs in the State, leveraging the highest amount of partner funding from Arts Queensland for a category one Council (populations under 5000).

The draft RADF guidelines from Arts Queensland have indicated a new percentage ratio table for funding eligibility that indicates that a co-investment of \$25,000 will enable the leveraging of up to \$40,000 for the 2016/2017 program.

RADF is a program that the communities of Blackall and Tambo have come to rely upon to deliver great Arts and Cultural projects. The investment of RADF funds is multiplied many times as the funds are expended by community groups delivering innovative arts activities and events.

The RADF program is highly valued and well utilised by the community.

# Purchase Of Sales Permit 201304400 From Millmerran Timbers Pty Ltd To Provide Cypress Sawlog Supply For The Tambo Sawmill

Blackall-Tambo Regional Council successfully purchased the Tambo Sawmill in July 2014 with the aim of providing employment for the community and stimulating the economy of the region.

After extensive lobbying for access to timber it became apparent that Council would need to purchase a Sales Permit to supply the mill with logs. An offer from Millmerran Timbers Pty Ltd of a Sales Permit containing access to 5700 tonnes per annum was received subject to approval of transfer of the harvest areas from the Millmerran district to proximity of the Tambo Sawmill.

A request to the Department of Agriculture and Fisheries, Forest Products to transfer Sales Permit 201304400 to Blackall-Tambo Regional Council has been approved. It is understood by DAF that Council proposes to lease the Tambo Sawmill as a commercial operation and as such the Lessee would be responsible for sourcing the required cypress sawlogs under the terms and conditions of Sales Permit 201304400 and for engaging any required harvesting and hauling contractors. Council however will be the holder of the Sales Permit and would remain responsible for compliance with its terms and conditions.

DAF will commence the preparation of the Operational Harvest Plan (OHP) once the contract of sale for the Sales Permit has been finalised. The preparation of the OHP takes a period of 3.5 months, it is therefore necessary

to formalise the purchase to contract stage to enable DAF to begin the OHP to ensure it is ready in time to open the mill by the end of September 2016.

Ministerial approval to finalise the contract of sale is required under caretaker provisions.
