That Council proceed with the compulsory acquisition of all existing native title rights and interests (if any) in the land described as lot 24 on SP300957, Title Reference 49005448, 47029178 and 49021969 and comprising an area of 46.82 hectares for waste management facility (refuse tip) purposes, and that the Chief Executive Officer prepare and the Mayor execute the necessary application for compulsory acquisition and forward the application and all required supporting documentation to the Department of Natural Resources, Mines & Energy in accordance with the requirements of the Acquisition of Land Act 1967 and relevant native title legislation."
